SANITSIATION PROTOCOLS



Aside from taking the precautions that we're all familiar with like maintaining social distance and awareness of possible symptoms, fleet operators can help in other ways too.



Can each driver have their own assigned vehicle?

Are your drivers provided with PPE such as face masks/shields, hand sanitiser or disposable gloves?

Have you provided cleaning/sanitisation equipment for each vehicle and instructions for when and how to clean?

Do you plan driver trips and routes ahead as much as possible to minimise unplanned stops and external contact?

Do you provide guidance on safe refuelling practices e.g. using disposable gloves and paying via mobile app?

Are you confident that your staff are adhering to company driving hours policy and take their full allocated time for breaks?

Are you monitoring vehicle health to avoid breakdowns by keeping up with preventative maintenance and monitoring of telematics data?

Do maintenance/repair appointments also allow time to disinfect vehicles to ensure social distancing?

Are you using digital solutions for drivers to access schedules, routes and messaging?

Are any vehicles not currently in daily use being regularly started/visually inspected?

ELECTRIC VEHICLES



As local governments continue to incentivise businesses to switch to Electric Vehicles, fleet managers need to make sure that they're fully equipped to maintain their safety standards no matter what. It might seem like just another kind of vehicle, but EVs actually mean additional considerations.

Do you carry out driver assessments to make sure drivers who are assigned EVs are suited to a different driving style (e.g. likely to consider regenerative braking distances/ not suffer range anxiety)?

Do you provide specific vehicle type training when transitioning drivers to EVs?

Do you give advice on what to do if an EV is involved in an accident, e.g. concerning discharge of HV batteries?

Do you provide instruction on home-charging process, e.g. use of 3 pin 13amp plugs, maintenance of installed charging units etc.?

Do you provide EV specific on-road training, to highlight operational differences, e.g. pedestrians being unaware of moving vehicles because of quiet running?
